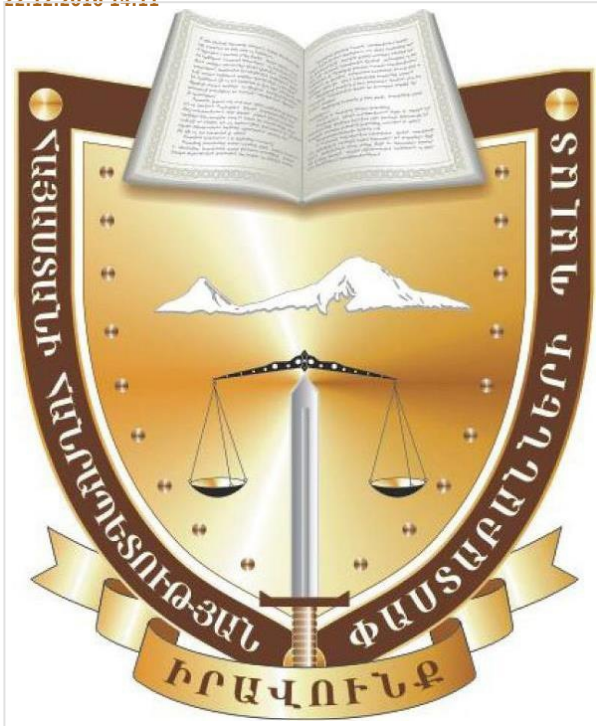


## ABOUT THE CONVENING OF A REGULAR SESSION OF THE GENERAL ASSEMBLY OF THE CHAMBER OF ADVOCATES OF RA

**Dear advocates,**

By the Decision of the Chairman of the Chamber of Advocates of RA from 21.12.2016 № 500-L that is “About the convening of a regular session of the general assembly of the Chamber of Advocates of the Republic of Armenia” **on the 11-th of February 2017 from 10:00 in the hall that is situated on the 2-nd floor of the administrative building of the Chamber of Advocates of RA (Zaqyan 2 street) by a distant method (without the calling of a general assembly) has been invited a regular session of the general assembly of the Chamber of Advocates of RA with the following agenda:**

**The election of the members of the Bar Council of the Chamber of Advocates of RA**

- **The election of persons preparing the disciplinary work of the Chamber of Advocates of RA.**

• **The issue of defining “Advocate’s day”.**

The **voting** on the issues of the agenda of the general assembly starts on the **11-th of February 2017, from 10<sup>00</sup> and terminates on the same day at 17:00.**

1. The **nomination of the candidates (self-nomination)** for the posts of the members of the Bar Council of the Chamber of Advocates of RA and persons preparing disciplinary work starts from the **14-th of January 2017 (inclusive) and terminates on the 19-th of January 2017 (inclusive).**
2. **The advocates can present proposals in connection with the defining of “Advocate’s day” according to the defined order from the 14-th of January 2017 (inclusive) to the 19-th of January 2017 (inclusive).**
3. The **propaganda of the candidates** for the posts of the members of the Bar Council of the Chamber of Advocates of RA and persons preparing the disciplinary work starts from the **20-th of January 2017 (inclusive) and terminates on the 9-th of February 2017 at 18<sup>00</sup>.**
4. Each advocate has to **participate in the voting personally.**
5. On the day of the voting one should arrive with an **identity document or an advocate license.**
6. The secrecy of the ballot is not only the right of the

voting advocate, but also – an obligation.

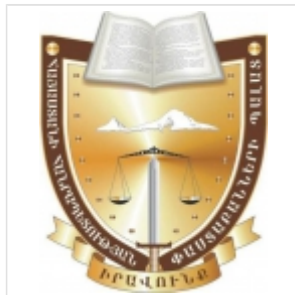
